DECLARATION AND UNDERTAKING BY PARENT / GUARDIAN

1. I, the undersigned parent / guardian of the abovementioned child, hereby declare that the particulars, as furnished, are to the best of my knowledge correct, and undertake :
 - 1.1 in the event of this application being successful and my child not making use of the accommodation, to accept liability for the full boarding fees for one school quarter, unless the committee having general supervision of the hostel decides otherwise;
 - 1.2 to give written notice not less than one month in advance of my intention to remove my child, except in cases where the committee has accepted shorter notice and, if I fail to comply herewith, to accept liability for the full boarding fees for the child until the end of the school quarter in respect of which notice should have been given :
 - 1.3 to pay the boarding fees payable, quarterly in advance, and
 - 1.4 to abide by the internal rules of the hostel.
2. The superintendent stands *in loco parentis* to all pupils in the hostel and is hereby empowered to act as such as my agent in all emergencies, medical or other matters.
